## I INTRODUCTION

1. The Council of Ministers of the Economic Community of West African States (ECOWAS) held its thirty-fourth ordinary session in the Conference Hall of the Community Headquarters Building at Abuja from 11 to 14 December, 1993. The following Member States were represented:

## II OPENING SESSION

3. The Chairman of Council, Honourable Paul DOSSOU, Minister of Finance of the Republic of Benin announced the passing away of His Excellency, President Felix HOUPHOUET-BOIGNY of Cote d'Ivoire. The Chairman paid glowing tribute to the memory of the departed ECOWAS Founding Father, and Council observed a minute of silence in prayer for the repose of his soul.

4. The Honourable Minister and Chairman of the National Planning Commission of the Federal Republic of Nigeria, Chief Silas B. DANİYAN opened the session on behalf of His Excellency General Sani ABACHA, Head of State and Commander-in-Chief of the Armed Forces of the Federal Republic of Nigeria who sent a message to Council.

5. In his message to the thirty-fourth session of Council, the Nigerian Head of State welcomed all delegations to Abuja and expressed the hope that the serenity of Abuja city would contribute to the success of their deliberations.

6. His Excellency General Sani ABACHA drew the attention of Council to the difficult economic situation of Member States and the effects on the West African economy of the sluggish recovery of the industrialised countries and the completion of the Single European Market. He said that Member States had a lesson to learn from the current strong regional cooperation drive of the Europeans, North Americans and the newly industrialising countries of the Pacific Rim. He stressed that the peoples of West Africa had placed their hopes in the success of regional integration and ECOWAS should not be allowed to falter.

7. The Head of State called for greater effort from all Member States to implement the many Community Acts and Decisions which, he stressed, were quite capable of alleviating the debilitating socio-economic development problems of Member States. General Abacha assured Council of the determination of his government to give all the necessary support to ensure the success of ECOWAS. In this regard, the Head of State promised that Nigeria would give favourable consideration to the ECOWAS request for assistance with the financing of its staff housing programme in Abuja.

8. In his welcome address, the Chairman of Council expressed the unreserved gratitude of Council and the Community to the Nigerian authorities and people for hosting the meetings, and for the very warm welcome and hospitality extended to all delegations. The Chairman introduced to Council the new Executive Secretary Mr. Edouard BENJAMIN as well as the other new Statutory Appointees namely:

The Chairman informed Council that the new Executive Secretary had already initiated certain measures to revitalise the Secretariat, and he enjoined the new team at the helm of Community affairs to pursue an effective and rational management policy.

9. In a brief review of the economic situation, the Chairman referred to the effect of the instability in the European currency market on several Member States. He stated that economic reforms continued in the region, and highlighted the tighter monetary and budgetary measures introduced by UMOA countries since August 1993. The Chairman, however, pointed out the limited capacity of individual countries to overcome the economic crisis and invited Member States to show greater commitment to regional cooperation and integration, which held the promise of economic salvation. In this connection he called for Member States' support of a new regional cooperation initiative announced in the interim report of the Executive Secretary.

10. The Chairman informed Council about the progress recorded on some of the Community activity programmes. He drew attention to certain difficult areas in the regional integration process such as the implementation of the programmes for trade liberalisation and free movement of persons, and the low level of contribution by Member States to the Community budgets. Commenting on the need for regional peace and stability, the Chairman appealed for greater understanding among the Liberian warring factions in order to accelerate the Liberian peace process.

V OUTCOME OF DELIBERATIONS

ITEM 4. Consideration of the Report of the Executive Secretary

13. The Executive Secretary presented his Interim Report, on the theme: "The Need for a New Vision to achieve Effective Integration". In his presentation, the Executive Secretary touched upon some recent developments in the international economic scene with a bearing on the West African economy. He referred, in particular, to European agricultural subsidies within the context of the Uruguay Round, and upheavals in the European currency market in August 1993. He also commented on the recent monetary and

budgetary measures instituted by UMOA countries and called for a closer study of the economic reforms being undertaken. The report called on Member States to make a joint representation to the EEC to review its policy of subsidised meat exports to the region.

14. The Interim Report reviewed progress made over the last few months in the execution of the Community Work Programmes. In the report, attention was drawn to the new initiatives taken by the Secretariat and FAO to assist the affected Member States in combatting the "White Fly" menace in the region.

15. During the introduction of the proposed 1994 Work Programme, the Executive Secretary invited Council to share his thoughts on the road to the future of West African development and integration. He raised a number of issues relating to national economic management, regional dimension of structural adjustment, and enhancement of ECOWAS integration programmes. He indicated that the problems identified should be given serious consideration by Member States. He made an undertaking that the institutions of the Community would endeavour to present to the next session of Council concrete proposals for its consideration and adoption. He assured Council that the new set of Statutory Appointees were determined to improve the functioning of the Community Institutions and appealed for the resources needed to make this possible.

16. Council congratulated the Executive Secretary for the quality of the report and the competent manner in which it was presented. After a general debate on the issues raised, Council took note of the report and made the following observations and decisions:

- i) The new management team had already shown proof of determination and commitment to improve the functioning of the Community Institutions and Member States should give the team every necessary support.

- ii) The recent initiative to exchange views and experiences on national structural adjustment programmes should be pursued. In this regard, the Secretariat was requested to collect and circulate information on economic reform programmes of all Member States, and continue with the formulation of the programme on the harmonisation of economic and financial policies.
- iii) It was important to achieve a coordinated regional approach to the mobilisation of external resources. Council called on Member States to confirm the mandate of ECOWAS to coordinate the preparation of regional projects and utilisation of resources allocated to West Africa under the Regional Fund of the Lome IV Convention. Council took note of Ghana's co-presidency of the ACP-EEC Council of Ministers and urged the Secretariat to seek the assistance of the Ghanaian authorities in its efforts to improve the utilisation of the Regional Fund. The Secretariat was requested to ensure that viable regional projects were identified and prepared for presentation to donors for financing.
- iv) Council endorsed the idea expressed in the report relating to the need to generate popular support for the ECOWAS integration programmes. To this end, Council called for the active involvement of the mass movements (youth, women, workers etc.) and economic operators, particularly in the private sector, in the regional integration process.

20. Council adopted the reports of the Committee and endorsed the appointment of the Statutory Officers of the Community made by the Chairman of Council. Council thanked the Committee for the excellent work done and enjoined the new Statutory Appointees to endeavour to revitalise the Community.

ITEM 7. Consideration of the Memorandum on the Composition of the Jury for the Award of the ECOWAS Prize for Excellence

21. The Secretariat presented the memorandum on the composition of the seven-member jury for the selection of winners of the ECOWAS Prize for Excellence in the field of African pharmacopoeia.

22. Council discussed the approved selection criteria, which had guided the Secretariat in proposing the composition of the jury presented to the meeting. Council directed that the Secretariat should review the selection criteria to ensure effective representation in future of the different cultural groups, the different official languages of the Community, as well as the inclusion of women on the jury. Council adopted the jury proposed by the Secretariat (as contained in the attached relevant decision of Council). Member States were urged to present candidates for the award of the ECOWAS Prize for Excellence and that these nominations should be made to the Secretariat without further delay.

ITEM 8. Consideration of Memorandum on a Minimum Agenda of Action for the Promotion and Sensitisation on ECOWAS

23. The Executive Secretary informed Council that, after a preliminary review of the content and implementation of the Minimum Agenda for Action, his new management team agreed that it needed more time to prepare the required memorandum for the consideration of Council. He gave the assurance that an exhaustive study of the

matter would be undertaken and definite proposals presented to the next session of Council.

24. Council directed that in preparing the report, the Secretariat should give an account of the implementation of the earlier Minimum Agenda for Action, and propose a successor programme, as requested by the Authority at the July 1993 Summit in Cotonou.

ITEM 9. Progress Report on the Study on Rationalisation of West African Inter-Governmental Organisations (IGOs)

25. The Secretariat informed Council that, due to some problems encountered with regard to the first instalment payment to the consultant undertaking the above study, it had not been possible to complete the study on schedule. Council was informed that the report would be submitted by the consultant at the end of March 1994 and that a meeting of Member States and Inter-Governmental Organisations will be convened to examine it and make recommendations to the next annual statutory meetings.

26. Council took note of the information and requested the Executive Secretary to ensure that the matter is considered at the 1994 annual statutory meetings.

ITEM 10. Consideration of the Reports of the Technical Commissions

(i) Administration and Finance Commission

27. The Chairman of the Commission presented the report on the twelfth meeting of the said Commission. Council adopted the report and recommendations of the Commission, and stressed the importance of the recommendations relating to the statutory appointees, and speculative placements such as SICAV operations.

Council further made the following observations and recommendations:

- (a) On ECOWAS Fund relations with ECOBANK Transnational Incorporated, a Committee made up of representatives from Ghana, Mali and Togo and the Managing Director of the Fund was set up to review the situation regarding the Fund's equity participation and placement of resources in that bank. The Committee was requested to make proposals which would take into account the financial interests of the Community, as well as the immediate and long term prospects of ECOBANK as a vehicle for regional integration.
- (b) Concerning the re-structuring of the capital of the Fund, Council welcomed the lifting of the reservation earlier made by Ghana, and the affirmation of that Member State that it had no objection in principle to the opening up of the capital to non-regional participation. Council, however, requested the Fund to make an analysis of its balance sheet and study the feasibility of inviting the participation of external partners. The Fund was also directed to make an in-depth study of the costs and benefits of the opening up of the capital of the Fund to external participation.
- (c) Council stressed the imperative need for the Institutions of the Community to observe faithfully all the decisions and directives of the authorities of the Community, particularly the financial rules and regulations. In this regard, Council requested that the accounting books and related documents should be made available to the External Auditors within the time-frame stipulated in the

Financial Regulations. Council directed further that steps should be taken to ensure the presence of the External Auditor at statutory meetings.

- (d) Council requested the Institutions of the Community to ensure that the regional programmes and projects proposed for adoption reflect the national economic priorities of Member States.
- (e) Council recommended that a letter of the Chairman of the Authority ~~should be sent~~ to Member States to draw their attention to the difficult financial situation of the institutions of the Community, and invite them to settle all their contributions. Council also requested its Chairman and the Executive Secretary to undertake a mission to Member States on this subject.

28. Council approved the Work Programme and an operational budget of the Executive Secretariat for the 1994 Financial Year balanced out at UA 7,114,900 in income and expenditure, representing a 12.8% reduction of the 1993 budget.

29. Concerning the new coefficients of contribution to be applied with effect from 1 January, 1994, which had been calculated in accordance with the provisions of the Protocol relating to the Contributions by Member States to the Budget of the Community, and the directives issued by the Authority at the Summit held from 22 to 24 July, 1993 at Cotonou, the representatives of the Republic of Cape Verde and the Islamic Republic of Mauritania entered reservations on the new coefficients.

*A* 30. The Chairman of Council was mandated to request the Chairman of the Authority of Heads of State and Government to get in touch

with the appropriate authorities of the two Member States concerned, so that the reservations could be lifted before 31 December, 1993.

ii) Trade, Customs, Immigration, Money and Payments Commission.

31. The report of the thirty-first meeting of the Commission was presented by the Secretariat. Council was informed that the Commission made the following recommendations:

- a. five new industrial products and four industrial enterprises had qualified for participation in the trade liberalisation scheme;
- b. adoption of a 19,321.800 UA compensation budget for 1994;
- c. approval of a draft protocol establishing a value added tax (VAT) in Member States and a request the Secretariat to prepare an accompanying manual of procedures;
- d. adoption of the Logo of the ECOWAS Trade Fair;
- e. the Fair should be held in Dakar from 25 May to 4 June 1995;
- f. the Fair should be launched in March 1994 in Dakar, Senegal and in all other Member States.

32. Council approved the report and adopted the recommendations following the lifting of the reservation of Senegal on the compensation budget.

33. Council underscored the important role of fairs in the promotion of intra-Community trade and urged all Member States to take every necessary measure to ensure the success of the first ECOWAS Trade Fair. Council noted with satisfaction the inclusion of the West African Women's Association (WAWA) as an observer in the Organising Committee of the First ECOWAS Trade Fair and recommended its participation in the Fair.

34. The delegation of Liberia drew the attention of Council and the Secretariat to the serious negative effect which the Liberian civil conflict has had on the implementation of the Community programmes in the areas of trade, customs, payments and immigration in that country. The delegation requested the assistance of the Community particularly in the convening of seminars in Liberia in these areas. Following this request from Liberia, Council requested the Secretariat to continue its assistance to Member States with regard to the sensitisation seminars on the ECOWAS trade, customs, payments and immigration programmes.

ITEM 11.                    Memorandum on the Ratification of the ECOWAS  
Revised Treaty and ECOWAS Protocols

35. In the presentation of this memorandum, the Secretariat stated that, as at 30 November, 1993 no instrument of ratification relating to the Revised Treaty had been received. The attention of Council was drawn to the Authority directive that the ratification process should be completed by 31 December, 1993 to enable the Revised Treaty to enter into force on 1 January, 1994.

36. Council noted during the discussions which followed the presentation that Member States had initiated the process of ratification of the Revised Treaty, but that the recent changes in administrative and parliamentary procedures in a number of countries accounted for the delays. Council urged all Member

States to pursue the matter with vigour to ensure that the instruments of ratification for the Revised Treaty and the outstanding protocols and conventions were deposited at the Secretariat as soon as possible.

**ITEM 12.**            **Memorandum on the Status of Member States' Financial Contributions to ECOWAS**

37. The Secretariat presented this memorandum and informed Council that outstanding contributions to the budget of the Secretariat stood at UA 21,197,371 as at 10 December, 1993.

38. During the ensuing discussions, a number of delegations informed Council about the reasons for the arrears of their countries and the steps being taken to clear those arrears. The Chairman expressed the gratitude of the Community to the Member States which had made the effort to clear or reduce their arrears. Council took note of the information concerning payments made by Burkina Faso and Nigeria, and urged Member States in arrears to endeavour to settle the outstanding contributions. Council recalled its decision that the Chairman should visit some of these Member States to discuss the matter with the competent national authorities.

**ITEM 13.**            **Any Other Matters**

i)    **Study on relations between ECOWAS Fund and ECOBANK ETI**

39. Concerning the financing of the study requested by Council to be undertaken on the relations between ECOWAS Fund and ECOBANK ETI, it was proposed that the Board of Directors of the Fund should make a provision in the 1994 operational budget of the Fund to cover the work of the Committee.



ii) Oath-Taking by Statutory Appointees

40. The issue of oath-taking by the new Statutory Appointees was raised during the consideration of the Council decisions on the ratification of their appointments. Council recalled that the normal practice was for the Executive Secretary to take the oath before the Authority of Heads of State and Government and the other Statutory appointees before the Council of Ministers. To this end, Council directed that the oath should be taken by Statutory Appointees as close to their appointments as possible and that in future, the ceremony should be explicitly inscribed as an item on the Agenda of the Authority or Council. Finally, Council decided that the new Statutory Appointees should take the oath during the 1994 Annual Statutory meetings.

iii) Maintenance of Community Property

41. The attention of Council was drawn to a few instances of damage to facilities in the Abuja Community Headquarters Complex. Council stressed the importance of maintaining the assets of the Community and directed that every necessary action should be taken to ensure that the new Headquarters Building and all other physical assets of the Community are well maintained.

ADOPTION OF REPORT


42. This report was adopted after amendment.

He underscored the importance of the opportunity that such ministerial meetings gave Member States to exchange views, consult among themselves and develop common approaches to their socio-economic problems. He expressed the satisfaction of Council with the determination shown by the Executive Secretary to mobilise the Community Institutions to face the development and integration challenges of the region. The closing session ended with the reading of the attached vote of thanks by the Honourable Amelia Ward, Minister of Planning and Economic Affairs of the Republic of Liberia.


Article 1

Payment of salary increments to staff of Community Institutions as provided under paragraph 2, Article 24 of the Staff

Regulations shall be temporarily suspended with effect from 1st January, 1994.

Article 2

The Executive Secretary shall advise Council as to the appropriate time to resume payment of salary increments to Staff of Community Institutions.

Article 3

This Decision shall enter into force on the 1st day of January 1994 and shall be published in the Official Journal of the Community and in the National Gazette of each Member State.

D E C I D E S

Article 1

An amount of nineteen million three hundred and twenty-one thousand eight hundred Units of Account (UA 19.321 800) is hereby approved as the 1994 compensation budget for loss of revenue resulting from the implementation of the trade liberalisation scheme.

Article 2

Contributions from 1990 stand at twenty-eight million six hundred and eighty thousand seven hundred and twenty-three Units of Account (UA 28 680 723). A breakdown of contributions to the budget is contained in Tables I, II and III attached hereto.

Article 3

Each Member State shall pay its contribution into the special fund being managed by the ECOWAS Fund which constitutes the permanent resource exclusively for the payment of loss of revenue incurred by Member States as a result of the implementation of the trade liberalisation scheme.



**MINDFUL** of Article 6 of the ECOWAS Treaty establishing the Council of Ministers and defining its composition and functions;

**MINDFUL** of Decision C/DEC.5/7/92 on the institutionalisation of the ECOWAS Trade Fair and the choice of a host country for the first ECOWAS Trade Fair;

**CONSIDERING** that the above decision states that Senegal has been chosen to host the first edition of the ECOWAS Trade Fair and that an eight member committee has been constituted;

**CONSIDERING** the need to publicise the ECOWAS Trade Fair and kindle public interest within and outside the Community in the activities and programmes of ECOWAS;

**CONVINCED** that adopting a permanent logo to be used during every edition of the ECOWAS Trade Fair will contribute effectively to the realisation of the above objectives;

**NOTING** that, on the recommendation of the Organising Committee, the Executive Secretariat organised a competition to select the best logo among entries submitted by nationals of Member States;

CONSIDERING that, having duly appraised the said entries, the Organisation Committee of the ECOWAS Fair recommended to the Trade, Customs, Immigration, Money and Payments Commission to accept the logo designed by Mr. Isaac Koffi Appiah.

ON THE RECOMMENDATION of the meeting of the Trade, Customs, Money and Payments Commission held in Lagos from 24 to 27 November 1993.

**D E C I D E S**

**Article 1**

The logo design submitted by Mr. Isaac Koffi Appiah is hereby approved for the ECOWAS Trade Fair.

**Article 2**

The logo for the ECOWAS Trade Fair shall present the following features:

A knotted cord around the flags of the sixteen Member States arranged in a circle within which is a white map of ECOWAS on a blue background. Within the circle formed by the flags of Member States and with the ECOWAS map as a background is a blue, white and black square crate tied up with a black rope and suspended from a hook of the same colour.



The Executive Secretariat shall assign to each enterprise a registration number which must feature on all the certificates of origin and on Customs declaration forms and shall inform Member States accordingly.




