TITLE: RECRUITMENT OF AN IT FIRM TO SUPPORT THE DEVELOPMENT OF ECOWAP E-LEARNING PLATFORM.

I. Context

The Economic Community of West African States (ECOWAS), represented by the Directorate of Agriculture and Rural Development (DARD), plans to finance a mission from its 2024 budget to **support the development of the ECOWAP e-learning platform**. To carry out this activity, the ECOWAS Commission plans to recruit a consultancy firm to *carry out the assignment*.

II. Objectives

The overall objective is to improve access to agricultural information that can create an enabling environment with quality, factual, and timely information that could help boost productivity and facilitate market access by (1) improving knowledge sharing on important issues for productivity, market access, access to finance through the implementation of e-learning, (2) improving farmers' learning through the implementation of an innovative capacity building strategy.

III. Mission of the firm

The firm's primary mission is to facilitate the development of a robust and effective e-learning platform that meets the information needs of young people, farmers, and researchers in the agricultural sector in West Africa.

The specific objectives are as follows:

- Developing a user-friendly interface for the e-learning platform.
- Integrate interactive features to improve user engagement and the learning experience.
- Develop APIs to ensure interoperability with ECOWAP's existing monitoring and evaluation system.
- Ensuring the scalability, security, and performance of the e-learning platform.

IV. Profile required of the firm

The firm must provide evidence of its technical capability to undertake this assignment. This includes its ability to deliver the results on time and evidence of previous experience (relevant capacity and expertise, training, and platform development).

- Proven experience in software engineering.
- Good experience in implementing web platforms using Agile or Scrum methodology.
- Demonstrate its capacity (staff and authorization) to train or transfer skills on the platforms and/or products used.
- Have developed and deployed at least 5 web and/or mobile applications in recent years,
- At least 3 years' professional experience in programming web and mobile applications,
- At least 3 years' solid experience in information systems management and web development
- Practical experience with network diagnosis and analysis tools,
- Experience in managing similar platform development projects.

V. Selection criteria

Applications will be assessed based on the following evaluation criteria and scoring scales:

Similar services not supported by legible copies of the cover sheets, signatures of the contracts performed, and certificates of successful completion will not be considered in the evaluation.

VI. Selection method:
