1. The ECOWAS Commission, acting through the Regional Agency for Agriculture and Food (ARAA), is soliciting bids in sealed envelopes for the "**supply and delivery of 5,027 tonnes of cereals to the Regional Food Security Reserve**", consisting of 5 lots identified below:
